1. Minutes

2. Student Course Feedback Committee

3. Proposed Change to Graduate School Policy

Chuck Wight presented. The current Graduate School policy states that students must maintain minimum registration of at least three credit hours. In order to monitor this, the Graduate School has to run a queery of all graduate students and have any students not in compliance register for the extra credits. The proposed change would remove the minimum credit hour requirement. Departments are welcome to enforce a higher level of registration.

4. Rise of TOEFL Scores

Donna White presented. The new TOEFL scores will rise from 500 to 550, and 61 to 80 in the new scale. This change will be implemented Spring 2014. This change has already been presented to the Directors of Graduate Studies with positive response. Departments are more than welcome to require higher TOEFL scores.

6. Proposal for a Graduate Emphasis in Care Management

Katie Ward presented. The new emphasis will be focused on the prevention of disease. The College of Nursing currently has three emphases within the MS in Nursing. The field of care management has grown and the School of Nursing anticipates sub specialties in geriatrics, pediatrics, etc. The College of Nursing would also like to discontinue the Clinical Nurse Leadership.

7. Ballet Updated Report

Linda Smith presented. The memo presented addressed the seven recommendations from the Graduate Council. The interim chair has researched the workload issue and hired an external consultant to review the department. Despite the consultant's recommendation, the Dean of the College of Fine Arts would like to start a search for a new chair in January. The department still needs more faculty and is one of a limited number of ballet programs in the country. A merger with the Modern Dance department will not be entertained at this time.
