Edward Clark, Matthew Peterson, Erika Lindley, and Jacquie Bernard were present for the proposal. The Institute will solidify and institutionalize a relationship between the groups involved in woman's and children's health. It will create a coherent, coordinated group which will become the #1 Women's Health Organization in the U.S. The Institute staff will develop best practices for long-term governance.
