# 2. Proposal for Graduate Emphases in the Master of Science in Nursing and the Doctor of Nursing Practice

#### 4. Graduate Council Review for Oncological Sciences

Ed Ruddell from the College of Health presented. The Oncological Sciences department is strong and has a strategic vision with outstanding resources, building, and staff. The six year program is only offered to graduate and Ph.D. students. Although the reviewers recommended growing the Department and hiring 6 new faculty members, the number of faculty has remained consistent due to a cycle of new hires but then retirements and retention issues. Huntsman Cancer Institute will be providing five faculty lines for one of the new hires. The question was raised about whether growing the program was in the best interest of the Department. Ed is revising the GC report to include suggestions made by Council members and it will be submitted to Associate Dean White.

The facilities have been identified as having safety issues. Despite funding and building issues, the morale is high and there is great leadership.
