### 1. Welcome and Introductions

Dean Kieda welcomed the Graduate Council to the second meeting of the 2015-16 academic year.

### 2. Thesis Defense Policy Discussion

David Kieda from the Graduate School

Supervisory committee chair denies setting a defense, should use 6-400 as rule to appeal fairness to both student and chair. Policy 6-400 describes procedure for student appeal of an academic action. The Graduate Council confirmed that scheduling a thesis defense should be considered an academic action, and so Policy 6-400 can be used to handle disputes regarding allowing a thesis defense to be scheduled.

### 3. Admissions Criteria Discussion

Donna White, Su'Ann Johansen (guest from Graduate Admissions)

Issues raised concerning admissions criteria. A comparison with PAC-12 institutions shows we are either lower (TOEFL minimum score) or equivalent to our peer institutions in our admissions standards. The Graduate Admissions Committee (GAC) reviewed requests from the Academic Senate leadership to discuss allowing exceptions to the minimum TOEFL requirement and to allow departments to grant more exceptions than those allowed currently by the Graduate Admissions Exception Rule. A summary of those discussions was presented by Associate Dean White (GAC Chair). There was substantial discussion and an agreement that the current TEOFL standard of 80 was very low and should not be lowered. The council expressed strong concern about the feasibility of student success if existing standards were lowered.

A question was raised regarding increasing the Graduate Council Admissions committee size. The consensus was not to increase the size or appoint an exofficio member.

Vote: Endorse current Graduate Admissions system as it is and invite faculty

to provide evidence of specific problems regarding admissions

standards; unanimous

Lopez and Emily Edmonson not being able to attend, the issue of English Language Proficiency options and three-year bachelor degrees will be discussed at the October meeting.

#### 4. Proposal: School of Dance

Brent Schneider from the Department of Ballet and Sarah Projansky from the College of Fine Arts presented a proposal for a new School of Dance.

# 5. CIB (Center, Institute, Bureau): Introduction for new members and review process proposal Donna White from the Graduate School

CIBs have not previously been reviewed and we are currently waiting for final approval of review process. CIB's on campus have been researched and are known; policy for new creation is flushed out. Option has been suggested that CIB administrator review annual reports and bring to the council for in-depth review only those with issues or concerns.

CIB being performed by the CIB administrator, with periodic reports to the Graduate Council. Identified problems will be brought forward to the Graduate Council by the Dean of the Graduate School for

### 6. Online Course Designation

Ryan Smith from Architecture and Planning

Online course designation was described. The course delivery method is overseen by the UOnline program, but is not currently linked to the curriculum committee or faculty of the degree program/college offering the degree. It is proposed that the council encourage department curriculum review of online course designation, and that faculty oversight of the outcomes assessment results and curricular modifications should be explicitly built into the UOnline initiative.
