Katrina Green provided members with an overview of program proposal process:

- Curriculum changes of less than 25% change can be fully approved at the department and college level.
- Curriculum changes over 25% must go through the full approval process.
- Expected timeline for approval workflow suggests that proposals should be considered at the Graduate/Undergraduate Council level by October to be approved before fall catalog goes live in April.
- New program proposals have an added step of going through a USHE peer review.

<u>Proposal:</u> Program Significant Changes >25% – Nursing Ph.D., Doctor of Nursing Practice (DNP), <u>Nursing MS</u>

Presenters: Julie Gee, Cynthia Beynon, Emily Winn, and Paula Meek, Nursing

Discussion took place about:

- AACN accreditation standards driving need for changes
- Two-year timeline to test and redesign curriculum
- Consolidated outcomes with credits remaining the same or decreasing slightly
- Alignment of revised outcomes with national standards and industry demand
- Nature of Ph.D. program
 - Serves working professionals
 - Extent of experiential learning
 - Comprehensive assessment
- Due to varying definitions of "competency-based education" (CBE), use of "competency-based" language in proposal could be confusing
 - o AACN's definition is different than NWCCU or Department of Education
 - "Competency-based" programs using the NWCCU definition require additional approval, which is not applicable for these programs.
 - o Curriculum is course-based
 - Assessments are based on competency attainment

<u>Proposal:</u> Program Significant Changes >25% and Name Change – Spatial Data Science MS Presenters: Simon Brewer and Neng Wan, School of Environment, Society, and Sustainability

Discussion took place about:

- Need for broader data skills
- Name aligns better with outcomes
- Name reflects disciplinary trends
- Various applications using word "spatial"
- Enrollment projections

The following concerns were discussed:

- Should have support from deans in the College of Science, College of Engineering, College of Humanities, and the School of Business
- Lack of comprehensive market analysis
- Need for better assessment plan with courses linked to outcomes
- Assessment plan should include remediation methods for when students do not achieve outcomes.

No vote was called on the proposal

Action: Provide feedback regarding Council concerns. Reconsider proposal at a future meeting.
